



SUMMARY ANNUAL REPORT HEALTH AND WELFARE PLAN

This is a summary of the annual report of the Cedars-Sinai Health and Welfare Plan (EIN 95-1644600, Plan Number 506) for the plan year July 1, 2021 through June 30, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Cedars-Sinai Medical Center has committed itself to pay certain uninsured claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Anthem Blue Cross, Delta Dental of California, Reliastar Life Insurance Company, Reliance Standard Life Insurance Company, Anthem Blue Cross Life and Health Insurance Company, MetLife Legal Plans and Berkeley Life and Health Insurance Company to pay health, dental, vision, life insurance, temporary disability, long-term disability, HMO, indemnity, legal, AD&D and stop loss claims incurred under the terms of the plan. The total premiums paid for the plan year ending June 30, 2021 were \$133,183,953.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending June 30, 2022, the premiums paid under such "experience-rated" contracts were \$119,383,188 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$108,554,044.

Paperwork Reduction Act Statement

According to the Paperwork Reduction Act of 1995 (Pub.
